### Pasta Bolognese

Serves: 4 to 6 Prep Time: 5 minutes Cook Time: 20 minutes

#### Ingredients:

- 1-1/2 lbs. ground beef
- 1 tsp. olive oil
- 1/4 cup dry red wine
- 2 Tbsp. chopped fresh basil
- 1 (24 oz.) jar Classico® Tomato & Basil Sauce
